**6. NOTICE TO APPLICANT**

Plumbing work shall not be started until the application for permit has been filed with Macomb Township. All installations shall be in conformance with the Plumbing Code.
<b>Expiration of Permit:</b> A permit remains valid as long as work is progressing and inspections are conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be closed when no inspections are requested and conducted within six months of the date of issuance or the date of a previous inspection. <b>Closed permits cannot be refunded or reinstated.</b>
